TERMS AND CONDITIONS

ON GOING PAYMENT TERMS: Buyer will make payment in full by the 10th of the following month of any invoice due. Service charges will be levied on overdue accounts at the maximum legal rate or 2% per month (24% per annum), whichever is less. All payments must be in United States funds. A \$25.00 service charge is assessed for wire transfers.

PROJECT ANIMAL PAYMENT TERMS: Buyer will make payment in full when auction check received, no later than October 31, 2014. No interest will be charged on this type of account. Credit card will be charged on November 1st if payment is not received.

SELLER'S LIABILITY: In the event any action is brought against Seller, under no circumstances shall Seller be liable for any amount greater than the purchase price of the product sold.

TAXES: Prices for any products do not include local, state or federal taxes, which shall be paid by Buyer.

DEFAULT AND REMEDIES: If Buyer becomes insolvent, fails to make any payment within the time required, or fails to perform any other obligation imposed by this Document or by law, Buyer shall be in default and Seller may immediately enforce any and all remedies provided by law.

SECURITY INTEREST: Seller may lien the products sold on credit and Buyer understands the obligations, provided that Seller must file all appropriate documents necessary to perfect his lien right. Buyer hereby further grants to Seller a security interest in all the products sold on credit and authorizes Seller to file a UCC financing statement perfecting said interest.

COSTS AND ATTORNEY FEES: In the event of a default, Buyer shall reimburse Seller for all costs and expenses reasonably incurred by Seller in connection with the default, including without limitation attorney fees. In the event suit or action is instituted to enforce any of the terms of this Document or for payment of any amounts owing, the Seller shall be entitled to recover from the Buyer such sums as the court may adjudge reasonable as attorneys' fees at trial; or on appeal of such suit or action, in addition to all other sums provided by law.

ASSIGNMENT: The rights and benefits of Buyer are personal to the Buyer and may not be transferred or assigned, voluntarily or involuntarily, without the prior written consent of Seller, which covenant may be withheld for any reason. Subject to this limitation, this Acknowledgment shall be binding upon and inure to the benefit of the parties, their successors and assigns.

WAIVER: No waiver of any provision shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless executed in writing by the party making the waiver.

GOVERNING LAW: The terms of the parties' agreement shall be governed by the laws of the State of Oregon. The parties agree that jurisdiction and venue shall be in Yamhill County, Oregon and the parties hereby agree and consent to this jurisdiction and venue, in that this Agreement has been made entirely in the State of Oregon. In the event that any suit or action is filed by either Buyer or Seller to enforce this agreement or otherwise with respect to this Agreement, venue shall be in the state courts in Yamhill County, Oregon.

NO THIRD-PARTY BENEFICIARIES: Nothing in this Agreement, express or implied, is intended to confer on any person, other than the parties to this Agreement, any right or remedy of any nature whatsoever.

ENTIRE AGREEMENT: Buyer agrees that this Document is the complete and exclusive statement of the agreement between the parties, which super cedes all proposals or prior agreements, oral or written, and all other communications between the parties relating to the subject matter of this acknowledgment. This Document can be altered, however, by different or additional terms contained, in a subsequent Document, invoice or change order issued by Seller. This Document will apply to all items charged and to all invoices for purchases made by Buyer.

I have read the terms and conditions of this Agreement, and agree to be bound by the same.

I authorize Seller to check my references and to obtain a credit report as part of this agreement. The references listed are authorized to disclose information about me or this business. I further understand that this credit line may be terminated at any time at Sellers sole discretion. Upon approval and acceptance by Seller all terms and conditions shall apply and Applicant is bound thereby.
